RE: Texas Public Water Systems Selected for U.S. EPA's Fifth Unregulated Contaminant Monitoring Rule (UCMR 5)

Dear UCMR 5 Texas Public Water Systems,

EPA wishes to reach out to Texas Public Water Systems (PWSs) regarding the requirements for the fifth Unregulated Contaminant Monitoring Rule (UCMR 5). The UCMR 5 requires certain Texas PWSs to collect drinking water samples for 29 per- and polyfluoroalkyl substances (PFAS) and lithium analysis during a 12-month period between 2023 and 2025.

To assist EPA with the UCMR 5, EPA is working with a contractor to conduct outreach to the UCMR 5 selected PWSs. The name of this contractor is the Great Lakes Environmental Center, Inc. (GLEC) that is based in Traverse City, Michigan. Outreach conducted can be through emails from the UCMR5@glec.com email address and/or by telephone from area code 231 or phone number 1-800-949-1581. EPA can verify that GLEC is a legitimate organization that is providing contractor support to the EPA for the UCMR 5.

Please also note that sampling for the UCMR 5 will be the responsibility of the PWS and not the Texas Commission on Environmental Quality's sampling contractor. Please ensure that PWS staff is aware of all sampling requirements, locations, and dates.
